Graduate Policies Charges

A new policy was approved by the Faculty Senate (Fall 2015).
- Review and recommend policies and procedures for developing deadlines for review of graduate assistantship applications, by university programs and offices, and for implementing guaranteed assistantships. Revised and developed new policies, procedures and models governing financial support (e.g., Bundled Admission-Assistantship Offers, Graduate Assistantships, Scholarships, Instructional Support, Tuition Waivers, modified timeline) of graduate students that will enhance recruitment and retention. A new policy was approved by the Faculty Senate (Spring 2016).
