## MINUTES OF THE SEPTEMBER 14, 2002 AND OCTOBER 18, 2002 BOARD MEETINGS:

The minutes of the September 14, 2002 and October 18, 2002 Board meetings were approved unanimously as distributed.

## **CHAIR'S REPORT:**

Gwen Taylor, Chair, reported that on December 5, 2002 a press conference was held to announce the establishment of the Russ Berrie Institute for Professional Selling at William Paterson University, with a \$5 million gift from Mr. Berrie. It is the first program of its kind in the northeast, representing an innovative partnership linking the private sector and a public university. It will provide new avenues of learning for William Paterson University students and business executives.

Dean Jess Boronico reported that The Cotsakos College of Business initially will offer a concentration in professional selling in the undergraduate business degree program, and subsequently will offer a full baccalaureate degree in professional selling. There will also be a certificate program available to students as well as the business community.

Ms. Taylor concluded by extending congratulations on behalf of the Board to the Dean, his staff, and all who were involved in the process that resulted in the selection of William Paterson University as the site for the Russ Berrie Institute for Professional Selling.

## PRESIDENT'S REPORT:

Dr. Speert reported that there would be four presentations. The first presentation would be made by Paul Merrill of KPMG Peat Marwick, who would report on William Paterson University's FY2002 audit. Mr. Merrill commented on the many changes in the financial reporting format as mandated following the adoption of several new accounting standards by the Government Accounting Standards Board (GASB). It was a challenge faced by all universities, and Mr. Merrill reported that the University met the challenge and complied with the new requirements.

Kurt Wagner, head of Library Information Systems, presented information on the expanded Library resources now available to students and faculty, including a much wider access of online databases, journals and full-text articles and the use of electronic reserves, resulting from our participation in the VALE consortium.

Sandra Miller, Director of Instruction and Research Technology presented information about the teaching and learning resources available to faculty and students, including the software program Blackboard. She shared some highlights from the Blackboard Fall Institute held at William Paterson for faculty in August, 2002 and the plans for future professional development training and collaboration with faculty.

Len Bogdon, Director of Information Systems presented information on planned upgrades to the University's administrative information systems. He provided a chronology of the University's implementation of information systems, component upgrades and the plans to upgrade our student, financial, human resource, alumni and library systems because they are nearing the end of their effective functioning.

Dr. Speert informed the Board and the audience of the death of Andrew Crawford, a William Paterson graduate, employee and former student trustee. A moment of silence was observed in his memory.

The Thanksgiving Dinner for Senior Citizens was held in November and was a tremendous success. The tradition was started here by Provost Sesay. Over 200 businesses, 63 individuals, student officers, student clubs, and over 150 of the William Paterson University community came together to provide a Thanksgiving dinner for 430 senior citizens from 43 different community or social service agencies. Lifetime Achievement Awards were given to Dr. Paul Chao, Dorothy Emerson, Vera Ames Garnes, Aleida Gines, and Veronica McGreevey, mother of Governor James E. McGreevey.

Our community counseling program was recently accredited for eight years by the Council for Accreditation of Counseling and Educational Programs (CACREP). Our school counseling program was accredited for two years.

On October 19, 2002 against New Jersey City University, our volleyball team celebrated their 400<sup>th</sup> win under Coach Sandy Ferrarella. Sandy has been Coach for 24 years. She is also accomplishing great things in the Admissions Office as a transfer student liaison.

The Women's Center will be conducting a mentoring program for women interested in the fields of engineering and science, and will celebrate the Center's 10<sup>th</sup> Anniversary in March. An update on the progress of the plans for renovation of the Student Center was provided.

## **DEVELOPMENT REPORT:**

Fred Gruel reported that our commitments this year are approximately \$7.9 million including the recent commitment of \$5 million from Russ Berrie. The Henry and Marilyn Taub Foundation has given a three-year commitment of \$285,000 to the Paterson Teachers for Tomorrow program. The Alumni Annual Fund is benefitting from a very successful phonathon. Donations increased from \$67,000 to approximately \$95,000 and the number of donors increased more than 35%.

Whereas Professor Carol Gruber has fulfilled all the requirements for Emeritus status as outlined in University Policy #9,

And whereas Carol Gruber has achieved recognition as a scholar, teacher and contributor to the William Paterson community,

And whereas Carol Gruber has been unanimously nominated by the History Department for Emeritus status.

Therefore, be it resolved that Professor Carol Gruber be awarded Emerita status, with all the rights and perquisites thereunto pertaining.

## History Department Recommendation to award Carol Gruber emeritus status

Professor Carol S. Gruber is a an outstanding teacher, scholar, and university citizen who should be given emeritus status in recognition of her twenty-five years of inspirational leadership as a faculty member at William Paterson University.

## Teaching Excellence and Inspiration

In the area of teaching excellence, Professor Gruber had an outstanding record in all respects. For twenty-five years, her courses in American History, and Historical Methods were vital offerings in the History major. Her special offerings in Society at War, Oral History, and many key areas of American history, including foreign relations of the United States and the Cold War and Nuclear America, expanded the experience of William Paterson University students and helped make the History major the success that it has become. She upheld the highest standards of teaching excellence and academic rigor within the major. Through her skill and encouragement as a teacher, she attracted numerous students to the study of history.

## Research and Scholarship

As a scholar in the field of American history, Professor Gruber was a dynamic member of a Department that placed high on its agenda the mission of spreading the word that William Paterson University is the home for outstanding scholars as well as exceptional teachers. Her book Mars and Minerva: World War I and the Uses of the Higher Learning in America won accolades, including Pulitzer Prize consideration, and Professor Gruber has earned honors, awards, and a formidable standing in scholarly circles for her research, publications, and active participation in the study of Science and War, Nuclear History, and American cultural history. She has published at least 17 articles and reviews in many prestigious publications.

Professor Gruber is a major figure in the study of universities, science and government in the US, particularly concerning the Manhattan Project for the development of the Atomic Bomb. She has participated in myriad panels, and has given numerous talks concerning the many issues related to those topics.

## Outstanding Service to University, College, and Department

There are few faculty who can demonstrate a longer record of active University service than Professor Gruber. She served as chairperson of the History Department for six years, and helped make the Department a leader in History in the state of New Jersey. She was founder of the Council of Chairs and its first Co-Chair, and she helped advance the cause of faculty governance in an increasingly complex environment. In 1999-2000, she was the leader and driving force behind William Paterson University's outstanding program to commemorate the arrival of the end of one era and the beginning of another. She has helped start the Provost's Distinguished Lecture series, which has brought numerous individuals of international reputation to the University community. In the early 1990s, she organized and secured funding from the New Jersey Council for the Humanities and the New Jersey Historical Commission for a major conference on the history of Paterson, New Jersey. A year earlier, she organized another major conference on the Pacific War, which was one of the preeminent Pearl Harbor commemorations in the country.

Carol Gruber has had an immeasurable impact on the University and the Department unanimously recommends her for emeritus status.
